


World Wetlands Day 2021: Protecting our Wetlands so that they can

The WOW factor and the Negril Great Morass

The Negril Great Morass, neatly nestled in the hinterland of Negril, provides a home for many species of endemic flora and fauna, makes Seven Mile Beach what it is, and is the site of Jamaica's IWEco National sub- Project.

In recognition of the site's importance to Jamaica's wetland targets, the Negril Great Morass featured in several learning activities for this year's World Wetland Day celebrations on 2nd February. It made waves on the Negril South River through the enactment of a Safari tour.

In alignment with the W.O.W. (Why Our Wetlands?) public awareness campaign, teachers from five schools in the Negril Environmental Protection Area participated in the ecotour. The activity sought to give teachers an appreciation of the biological and ecological significance of the area. This 'Train the Trainer' approach was adapted to provide support for the effective delivery of environment-related lessons to their students. The activity was also meant to provide a foundation for interactive class sessions to be rolled out in coming months in the various schools participating in the W.O.W. campaign.

IWEco and CANARI:
Supporting nature-based enterprises and

sustainable livelihoods

One of the aims of the GEF IWEco Project is to assist in the development and strengthening of nature-based enterprises in and around national sub-project sites. Following Recommendation 10 of the IWEco Mid-Term Review (MTR), the Caribbean Natural Resources Institute (CANARI) is beginning a two-year project under IWEco to strengthen and support stewardship and sustainable and climate-resilient livelihoods in IWEco countries to in turn facilitate healthy and resilient ecosystems. This will be achieved through the implementation of four inter-linked intervention areas:


- Enhancing ecosystem stewardship to support sustainable livelihoods of surrounding communities: Activities to build the capacity of community naturebased entrepreneurs and resource users in the surrounding communities to take stewardship actions to protect ecosystems upon which their livelihoods and wellbeing depend.
- 2. Strengthening community enterprises to ensure sustainable use and enhance socio-economic benefits to surrounding communities: Nature-based community enterprises/SMEs which are dependent on local natural resources (goods or services) for their operations and processes will be targeted to establish and/or strengthen their capacity to deliver triple bottom line (environmental, social and economic) co-benefits.
- 3. **Building resilience of livelihoods to climate change:** Activities to 'climate proof' community nature-based enterprises in the target GEF-IWEco countries.
- 4. **Knowledge sharing for sustainable nature-based livelihoods:** Activities to scale out approaches such as ecosystem stewardship, business strengthening and climate proofing beyond the target SMEs and project life cycle.

This project will be introduced by CANARI at IWEco's next two Partners' Webinars. On 2nd March 2021, the 13th Partners' Webinar will focus on the role of National Project Coordinators and National Focal Points, and on 16th March 2021, the 14th Partners' Webinar will look at the possible roles of the GEF Small Grant Project (SGP) Coordinators in participating countries and the Caribbean Youth Environment Network (CYEN).

Stay tuned for more information about this initiative which we believe is important for the sustainability of the IWEco approach in participating SIDS.

Making Peace with Nature

"The COVID-19 pandemic, which was still unfolding at the time of the completion of this report, illustrates why the transformation to a sustainable future needs to be accelerated. Science plays a pivotal role in informing policies that can drive this transformation, and a key area that needs to be better understood is the interaction between society and nature. The emergence of new infectious diseases in humans, animals and plants can be exacerbated by human activities. Activities that contribute to ecological degradation can increase the risk of zoonotic-origin disease from wildlife through increased human contact with pathogens and changes in pathogen ecology. These activities include climate change, land-use change and fragmentation, agricultural intensification, deforestation, and legal and illegal commercial wildlife trade."

On 18th February, the first UNEP synthesis report titled: "Making Peace With Nature: A scientific blueprint to tackle the climate, biodiversity and pollution emergencies" was launched ahead of the fifth United Nations Environment Assembly (UNEA-5). It is based on evidence from global environmental assessments and communicates how climate change, biodiversity loss and pollution can be tackled jointly within the framework of the Sustainable Development Goals.

"The resulting synthesis communicates how climate change, biodiversity loss and pollution can be tackled jointly within the framework of the Sustainable Development Goals. The report serves to translate the current state of scientific knowledge into crisp, clear and digestible facts-based messages that the world can relate to and follow up on."
